Keeping these records current, will facilitate the timely receipt of dividends and other shareholder benefits.

Since dividends on shares are payable only through electronic mode for shareholders with unpaid or unclaimed dividends, the amount will be credited to the shareholder's bank account only after the required information/documents are updated. Physical shareholders are requested to complete/update their KYC updates in the manner given hereunder.

Shareholders are requested to approach Company/RTA to claim such dividend to avoid transfer of same to IEPF authority. Important Notice to Shareholders:

Members of the Company are requested to check and claim any unpaid or unclaimed dividend amounts, if applicable, for the final dividend pertaining to the financial year 2017–18 and onwards. To initiate the claim process, shareholders are advised to submit a formal request to the Company's Registrar & Transfer Agent (RTA) – MUFG Intime India Private Limited (formerly Link Intime India Private Limited).
